

Licence to publish

1. For the purpose of publishing the WORK:

(including but not limited to graphs, figures, tables, artwork, or abstracts submitted with the WORK) in the *Vodohospodářské technicko-ekonomické informace* (VTEI) journal, the holder of rights to the WORK hereby grants T. G. Masaryk Water Research Institute, p. r. i., Podbabská 2582/30, Prague 6, 160 00, Czech Republic, IČ 00020711 for the entire duration of the rights to the WORK and any extension thereof, a non-exclusive, irrevocable license to publish, reproduce, distribute, transmit, display, store, and translate the WORK in the VTEI journal under license [Creative Commons Attribution-NonCommercial 4.0 International \(CC BY-NC 4.0\)](https://creativecommons.org/licenses/by-nc/4.0/) in any language or in any form, format, or medium now known or hereafter developed without limitation throughout the world. In the event that VTEI chooses not to publish the WORK, this license will terminate.

2. Ownership of the rights to the WORK remains with the authors and rights holders, provided that when reproducing the WORK or extracts from it, they state the first publication of the WORK in VTEI.

3. Owners of rights have in particular (but not only) the right to:

5. The authors authorize T. G. Masaryk Water Research Institute, p. r. i., to take the steps it deems necessary at its own expense and on behalf of the authors if it believes that a third party is infringing or likely to infringe copyright to the WORK.

6. In the event that the WORK was created by an employee as part of his/her employment, the license recognizes the employer's reserved right to make copies of the WORK for its own internal use.
